



HOW TO COMPLETE A WKA MEMBERSHIP APPLICATION

In order to expedite the processing of new and renewal WKA membership applications, please read the following information:

Master Members:

Anyone applying to WKA as a Master Member **MUST** be at least 18 years of age. Fee is \$55 per Master Member. If you **RENEW** your license by mail to the WKA office prior to it's current expiration, you may deduct \$5 off the fee and pay only \$50. If you currently have a membership, be sure to include the WKA License number on the application.

Associate Members:

The spouse of a Master Member and children under 18 years of age are considered as Associate Members. Fee is \$15 per person. If you currently have a membership, be sure to include the WKA License number on the application. You must have a Parental Consent Form completed by the parent of the minor applicant attached to the application. Birth Certificates are required to be sent to WKA once. An Associate Member must have a Master Member.

Road Racing Endorsements are \$10 each. Sprint class 1 license endorsements are \$5 each. The endorsement application is required each year, must be completed in full and submitted along with the membership application.

1. Complete the Master and/or Associate Membership Information.
2. Sign the Master Member signature line on the WKA Membership Application page and include date.
3. Master Member must sign the Master Member signature line on the Agreement of Release page. Associate Member signatures are requested. A witness to the signature is asked. The application **CANNOT** be processed without this signature.
4. Master Member must sign, print name and date the Parental Consent Form for all Associate Members under 18 years of age. Please complete additional consent forms if there is more than one minor.
5. Complete the License Endorsement Application if you are requesting an endorsement to race shifters in the Mfr Cup Series and / or competing in the National Road Racing Series. Refer to the WKA Tech Manual for endorsement requirements.
6. Mail all originals to the WKA Office. Fax copies are not accepted.
7. Payment is accepted via check, money order, credit card or cash if paying in person (do not mail cash).
8. Auto-Renewal Option - WKA offers an auto renewal option. If you denote payment by credit card and initial the Auto Renewal Option, we will automatically renew your membership each year until you advise otherwise. If you have an Associate Member under 18, we will require an updated Parental Consent Form for the minor every two years.
9. Make sure all information is printed legibly. If you cannot read it, neither can we.
10. If you submit your membership application anywhere other than directly to the WKA Office, get a receipt.

The WKA office receives a large amount of applications that are missing some or all of the required information. This requires us to contact each applicant by phone, fax, email, etc to get this information prior to processing the membership application. This delays the membership process and the driver does not receive his/her WKA membership card in a timely manner. Help us help you by completing all forms in full and supplying the necessary additional information where applicable.

AGREEMENT OF RELEASE

IN CONSIDERATION of being granted the benefits of membership in the World Karting Association:

1. THE UNDERSIGNED, for myself, my personal representatives, heirs, next of kin, successors and assigns, DO:
 - a) HEREBY AGREE TO ASSUME ALL RESPONSIBILITY AND LIABILITY FOR ALL ACTS OR ACTIVITIES of myself, my drivers, assistants and crew for any and all damage or injury that may be caused by any or all of us or by our kart, motor, properties or possessions in any way growing out of or resulting from the operation of my equipment and/or as a result of our participating in a World Karting Association event or time trial during the actual sanctioned period.
 - b) HEREBY AGREE to be bound by all of the rules of the Association and agree that decisions of its officials and/or interpretation of its rules will be governed exclusively by the administrative review and appeal procedure set forth in such rules and HEREBY AGREE TO WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE WORLD KARTING ASSOCIATION or its corporate, elected and appointed officials, all members of committees, referees and inspectors regarding the administration, review and appeal procedure set forth in the rules and regulations.
 - c) HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE WORLD KARTING ASSOCIATION as an association including all its corporate, elected and appointed officials, all members of committees, referees and inspectors, its individual members, its member clubs, agencies of government which control essential land sites, financiers and firms which render essential service gratis, including all officers, agents and employees of the foregoing and volunteer workers assisting in sanctioned WKA race and time trial activities, all hereinafter referred to as "Releasees" from or for any and all liability to me, my personal representatives, heirs, next of kin, successors and assigns, for all loss or damage for bodily injury, death or damage to property of the undersigned which in any way grows out of or results from any WKA race or time trial activity or part thereof, during the actual sanction period and whether any such claim may be based upon alleged active or passive negligence whether caused by the releasee or otherwise, or participation in duty the wrong, or upon any alleged breach of any statutory or obligation, and
 - d) HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
 - e) HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.
 - f) THE UNDERSIGNED EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE ACTIVITIES OF THE EVENT ARE VERY DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE: THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
 - g) HEREBY ACKNOWLEDGE AND AGREE that I have no right, property or interest in any radio or television broadcast, motion pictures, still photographs, tape or sound reproduction taken, made, transmitted, reproduced, or used for any purpose of any WKA sanctioned events, including practice, qualification, the race, awards ceremonies or other events associated with the racing event, also including, but not limited to pictures and sound of me alone or with other persons, with or without racing equipment, as well as any and all receipts therefrom, and any transcriptions thereof.
 - h) IN CONSIDERATION OF THEIR PROMOTIONAL EFFORTS ON BEHALF OF THE SPORT, I hereby assign all commercial communication and broadcast rights to the World Karting Association, and do declare it as my lawful agent and representative regarding such rights. I AGREE that WKA, or its assigns, on a non-exclusive basis, may use my name and pictures, including pictures of my racing equipment, and pictures taken at any sanctioned event for publicity purposes.

BY VOLUNTARILY AFFIXING MY SIGNATURE BELOW, I WARRANT THAT I have read and understand all of the foregoing. I accept the valuable BENEFITS OF MEMBERSHIP as good, valid and adequate consideration; the statements in my application are true and the releasees will rely on them and upon all my commitments in entering into a membership contract with me.

IN CONSIDERATION of my minor child being permitted in RACING PROGRAMS, to enter for any purposes the RESTRICTED AREA (herein defined as, including but not limited to the racing surface, pit areas, infield, burn out area, approach area, shut down area, and all walkways, concessions, and other appurtenant areas where any activity related to the event shall take place or where special authorization, permission, or credentials are required or where admittance to the general public is restricted or prohibited), or to compete, officiate, observe, work for or for any purpose participate in any way in the event, I agree:

1. I know the nature of the EVENT(S) and the Minor's experience and capabilities, and believe the Minor to be qualified to participate in the Event(s). I will inspect the premises, facilities, and equipment to be used or with which the Minor may come in contact. IF I OR THE MINOR BELIEVE ANYTHING IS UNSAFE, I WILL INSTRUCT THE MINOR TO IMMEDIATELY LEAVE THE RESTRICTED AREA AND REFUSE TO PARTICIPATE FURTHER IN THE EVENT(S).
2. I FULLY UNDERSTAND and will instruct the Minor that: (a) THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and participation in the Event(s) and/or entry into Restricted Areas involve RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by the Minor's own actions, or inactions, the actions or inactions of others participating in the Event(s), the rules of the Event(s), the condition and layout of the premises and equipment, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS NOT KNOWN TO ME or that are not readily foreseeable at this time; (d) THE SOCIAL AND ECONOMIC LOSSES and/or damages that could result from those Risks COULD BE SEVERE AND COULD PERMANENTLY CHANGE THE MINOR'S FUTURE.
3. I consent to the Minor's participation in the Event(s) and/or entry into Restricted Areas and HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.
4. I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any persons in any Restricted Area, sponsors, advertisers, owners, and lessees of PREMISES used to conduct the event, premises or event inspectors, surveyors, underwriters, consultants and other persons or entities who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S), and each of them, their officers, directors, agents, and employees, all for the purposes herein referred to as "RELEASEES," FROM ALL LIABILITY TO ME, THE MINOR, my and the Minor's personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON ACCOUNT OF ANY INJURY, including, but not limited to, death or damage to property, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE.
5. LICENSE ENDORSEMENT EXPLANATIONS & REQUIREMENTS

Each applicant will be issued one license endorsement based on the Series and Class(es) entered at the top of this form. Restrictions may be applied to any endorsement and/or the endorsement may be issued on a provisional basis. Driver requirements for each endorsement are listed below, but WKA may recognize similar experience from other WKA series or other national race-sanctioning organizations. The below endorsements are listed in order beginning with the highest license endorsement obtainable with WKA. If the applicant possesses an endorsement listed for or below your class, then the applicant is eligible to compete in lower classes. RR1 & RR2-Shifter licenses are honored for the Mfr Cup ICC Shifter class.

•Road Racing (Enduro) Class 1 **\$10 fee** **(Level 1)** **You must be at least 18 years old to apply for this license**
 Required for the following Road Racing (long track) classes/categories: •250cc Twin •B Stock •Formula 125 •Unlimited and any other classes as noted in the WKA Tech Manual and its updates. This license is the highest level of license endorsement in the WKA. It is issued for the "upper level laydown" classes within the Road Racing Series. WKA requires the applicant to have participated in and list his or her last 2-years driving experience with at least 5 events per year. It is reserved for those drivers that demonstrate superior driving abilities and requires evidence that applicant is of sufficient experience and ability.

•Road Racing (Enduro) Class 2 - Shifter **\$10 fee** **(Level 2-A)** **You must be at least 18 years old to apply for this license**
 Required for the following Road Racing (long track) classes/categories: •CIK 125 Sprint Shifter and •WKA/ICC 125 Sprint Shifter and any other classes as noted in the WKA Tech Manual and its updates. This license is designed for the 125 Sprint Shifter classes in the Road Racing Series. All Road Racing 125 shifter competitors are required to carry this level endorsement or better. WKA requires the applicant to have participated in and list His or her last 2-years driving experience with at least 5 events per year. It is reserved for those drivers who demonstrate superior driving abilities and requires evidence that the applicant is of sufficient experience and ability.

•Road Racing (Enduro) Class 2 - TaG **\$10 fee** **(Level 2-B)** **You must be at least 16 years old to apply for this license**
 Required for the following Road Racing (long track) classes/categories: •Spec 125 Sprint •Spec 125 Sprint R&D •Formula 100 (laydown) & •2-Cycle Open Sprint and any other classes as noted in the WKA Tech Manual and its updates. This license is designed for the Spec 125 Sprint (Touch-and-go aka TaG), 2-Cycle Open Sprint classes and the Formula 100 laydown class in the Road Racing Series. All competitors listed in this category are required to hold this level endorsement or better. WKA requires the applicant to have participated in and list his or her last 1-year driving experience with at least 5 events per year. It is reserved for those drivers that demonstrate advanced driving abilities and requires evidence that applicant is of sufficient experience and ability.

•Sprint Class 1 **\$5 fee** **(Level 2)** **You must be at least 15 years old to apply for this license**
 Required for the following sprint (short track) classes/categories: •125 (ICC) Sprint Shifter and any other classes as noted in the WKA Tech Manual and its updates. This license is designed for the 125 sprint shifter classes within the George Kugler Manufacturer's Cup & Stars Series. WKA requires the applicant to have participated in and list his or her last 2-years driving experience with at least 5 events per year. This license is an advanced level license and requires evidence that applicant is of sufficient driving experience and ability.

•Road Racing (Enduro) Class 2 **\$10 fee** **(Level 3)** **You must be at least 12 years old to apply for this license**
 Required for the following Road Racing (long track) classes/categories: •ALL Road Racing Series classes EXCEPT those listed under Road Racing Class 1, Road Race Class 2 Shifter and Road Race Class 2 TaG. This license is for all Road Racing competitors as outlined above. All Road Racing classes require at the minimum, this endorsement, whether it's a sprint or laydown style kart. WKA requires the applicant to have participated in and list his or her last 12 months racing experience.

•Sprint Class 1 - Junior **\$5 fee** **(Level 4)** **You must be at least 12 years old to apply for this license**
 Required for the following sprint (short track) classes/categories: •80cc Shifter Jr class and any other classes as noted in the WKA Tech Manual and its updates. In order to qualify for this license, the applicant must have run at least 2 national events in any of the following organizations over the past calendar year: WKA, IKF or SKUSA.

•Sprint Class 2 **No additional charge**
 This is the general license granted with all WKA Membership applications. There is no additional fee or requirements for this license endorsement as it is part of the basic membership. All references to the license will discontinue beginning with the 2007 season.
